

Cycling New Zealand - Selection Regulation Schedule 1 - Track (Elite) Selection for UCI 2024 Track World Championships Date of Issue - 20 March 2024

1. General Selection Regulation and this Schedule

- 1.1 This Schedule 1 is a schedule to the Cycling New Zealand General Selection Regulation (last updated 6 March 2024) (General Selection Regulation) for selection of the Elite Track Team to the 2024 UCI Track World Championships. Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise.
- 1.2 If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

2. Selection Objective

2.1 Cycling New Zealand's objective for the 2024 UCI Track World Championships is to win as many medals as possible in individual events.

3. Eligibility Requirements

3.1 All riders seeking selection to the Elite Track Team must complete the Rider Application by providing all information requested in the online Rider Application by the date set out in clause 6 below.

4. Selection Criteria

- 4.1 The Selection Panel will select riders it considers are capable of winning medals at the 2024 UCI Track World Championships. In considering which Eligible riders will satisfy the Selection Objectives and this criteria, the Selection Panel:
 - 4.1.1 must consider Eligible riders' performances at any one or more of the competitions in the Table 1 below during the Elite Track Performance Window (defined in the Key Timelines in clause 6 below);
 - 4.1.2 may consider any one or more of the Discretionary Considerations (in clause 4 of this Schedule); and,
 - 4.1.3 may take into account any Extenuating Circumstances (in accordance with clause 8 of the General Selection Regulation).

5. Discretionary Considerations

- 5.1 The Selection Panel may consider any other information it considers relevant in considering the riders to select, such as:
 - a. a rider's ability to win a medal in more than one Event;
 - b. a rider's ability to enhance or support another rider to win a medal in an Event;
 - c. the opportunity provided by the 2024 Track Championships to develop a rider who has the potential to achieve selection for future Pinnacle Events;
 - d. a rider's training, planning, and availability in the months leading into the 2024 UCI Track World Championships;
 - e. the conditions in which results and performances were obtained, including but not limited to the nature of the course, equipment used, environmental factors, team composition, and level /field of competition;
 - f. the rider's results and performances outside of the competitions listed in Table 1, including in-competition, training, or trials, within the Performance Window;
 - g. the results of a rider's testing, assessment and training data outside of competition, during the Performance Window;
 - h. the number and nature of Events in which a rider may compete at the 2024 Track Championships;
 - a rider's attendance, and conduct at past competitions, training sessions, training camps, testing sessions, assessments, and other events; and
 - j. a rider's performance behaviours, including active engagement in individual performance planning (IPP) process, ambition, attention to detail, and ability to perform under pressure;
 - k. any other relevant matter that is reasonable to consider.



5.2 **Relevance & Weight:** The Selection Panel has absolute discretion to determine the relevance and weight of any of the Discretionary Considerations and any Extenuating Circumstances as it sees fit.

6. Key Timelines

6.1 The Elite Track Team will be selected in accordance with the Key Timelines set out below, unless Cycling Ne Zealand needs to change those dates for reasons outside of its control.
