Schedule 1A -Track - Junior (U19)
Selection for 2024 UCI Junior Track World Championships
Date of Issue - 21 December 2024

1. General Selection Regulation and this Schedule

- 1.1 This Schedule 1A is a schedule to the Cycling New Zealand General Selection Regulation (last updated 6 March 2024)(General Selection Regulation) for selection of the Junior Track Team to the 2024 UCI Junior Track World Championships.
- 1.2 Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise. If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

2. Selection Objectives

- 2.1 Cycling New Zealand is required by the UCI to attend the 2024 UCI Junior Track World Championships in order to enter riders into the 2024 UCI Elite Track World Championships. Cycling New Zealand's objective is therefore to select eligible junior riders that it considers:
 - 2.1.1 will benefit from the opportunity of competing at international level to continue their development; and
 - 2.1.2 show potential for medal success in elite classes at future World Championships.

3. Eligibility Requirements

3.1 All riders seeking selection to the Team must complete the Rider Application by providing all the information requested in the online Rider Application Form by the date set out in clause 6 below.

4. Selection Panel's Considerations

- 4.1 In considering which Eligible riders will satisfy the Selection Objectives, the Selection Panel:
 - 4.1.1 must consider and give weight to Eligible riders' results and performances at one or more of the following competitions:
 - a. 2024 Oceania Track Cycling Championships;
 - b. 2024 Cycling New Zealand Track National Championships;
 - c. 2024 Regional Track Cycling Championships;
 - 4.1.2 must give primary weight to Eligible riders who meet any one or more of the Primary Performance Standards in Table 1 below within the Performance Window (defined in the Key Timelines in clause 6 below).
 - 4.1.3 if there are positions still available in the Team not filled by considering riders under clause 4.1.1 and 4.1.2, or to consider riders in team Events (i.e. Teams Pursuit, Team Sprint) the Panel must give secondary weight to Eligible riders who meet any one or more of the Secondary Performance Standards in Table 1 below;
 - 4.1.4 may consider results and performances at any competitions in the Performance Window in Teams Pursuit & Team Sprint, Omnium (incl. the individual events making up the Omnium), Madison & Keirin when considering selection of the Team;
 - 4.1.5 may consider any one or more of the Discretionary Considerations (in clause 5 of this Schedule); and,
 - 4.1.6 may take into account any Extenuating Circumstances (in accordance with clause 8 of the General Selection Regulation).

5. Discretionary Considerations

- 5.1 The Selection Panel may consider any other information it considers relevant in considering the riders to select, such as:
 - the opportunity provided by the 2024 UCI Junior Track World Championships to develop a rider who has potential to achieve selection for future pinnacle events.
 - a rider's ability to train and compete with others in team events (e.g. Team Pursuit, Team Sprint, and Madison);
 - c. the conditions in which results and performances were obtained, including but not limited to the nature of the venue, equipment used, environmental factors, team composition, and level of competition;

- d. a rider's performances outside of competitions listed in clause 3.1.1 within the Performance Window, including in competition, training, or trials;
- e. the number and nature of Events in which a rider may compete at the 2024 UCI Junior Track World Championships;
- f. a rider's attendance, and conduct at past competitions, training sessions, training camps, testing sessions, assessments, and other events;
- g. any other factor that it considers is reasonable to take into account.
- 5.2 **Relevance & Weight:** The Selection Panel has absolute discretion to determine the relevance and weight of any of the Discretionary Considerations and any Extenuating Circumstances as it sees fit.
