All Individual Members (as defined in clause 35.1 of the Constitution) and Delegates of Member Organisations (duly appointed in accordance with clause 24.15 of the Constitution) are eligible to attend the Annual General Meeting along with Board Members.

# **NOTIFICATION OF DELEGATES, ATTENDANCE AND VOTING:**

Pursuant to clause 24.4(b) of the Cycling New Zealand Constitution, the Chief Executive must be notified of the Delegate(s), any Members attending, proxy forms, and Postal or Electronic Votes for the Annual General Meeting by the 19th of April, 2024.

Per Cycling New Zealand's Constitution, only the following persons are eligible to vote at the Annual General Meeting:

- Member Organisations Each MO shall be entitled to one (1) vote provided the MO has complied with the requirements specified in the Constitution.
- The Chairperson but solely for the purposes of a casting vote (clause 25.3).

#### **BOARD MEMBER ELECTIONS:**

We are calling for nominations for three (3) Elected Board Member positions prior to the Annual General Meeting.

- Melanie Short steps down at the 2024 AGM and the position created by this vacancy is for a 2 year casual vacancy through until the 2026 AGM.
   The successful candidate may be re-elected for an additional 4 year term.
- Steve Stannard stepped down in 2023 and the position created by this
  vacancy from the 2024 AGM is for a one year casual vacancy. The
  successful candidate may be re-elected for an additional two
  consecutive terms of office.
- Cath Cheatley stepped down in 2022 and the position created by this vacancy from the 2024 AGM is a four-year term. The successful candidate may be re-elected for an additional 4 year term.

Nominations should be sent as per the constitution to the Cycling New Zealand Chief Executive not less than 30 days prior, by Friday 19th April 2024.
