

Schedule 2A – Road– Junior (U19)

Selection for 2024 UCI Road (U19) World Championships

Date of Issue – 21 December 2023

1. General Selection Regulation and this Schedule

- 1.1 This Schedule 2A is a schedule to the Cycling New Zealand General Selection Regulation (last updated 6 March 2024) ([General Selection Regulation](#)) for selection of the Junior Road Team for the 2024 UCI Junior Road World Championships.
- 1.2 Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise. If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

2. Selection Objectives

- 2.1 In considering riders for selection for the 2024 UCI Junior Road World Championships, the Selection Panel will select Eligible riders it considers:
 - 2.1.1 will benefit from the opportunity of competing at international level to continue their development; and
 - 2.1.2 show potential for medal success in elite classes at future World Championships.

3. Eligibility Requirements

- 3.1 All riders seeking selection to the Team must complete the Rider Application by providing all information requested in the online Rider Application Form by the date set out in clause 6 below.

4. Selection Criteria

- 4.1 In considering with Eligible riders satisfy the Selection Objectives, the Selection Panel:
 - 4.1.1 must consider, and give weight to, Eligible riders' results and performances at any of the competitions in Table 1 below;

- 4.1.2 must consider the riders which it considers are the most capable of achieving the Selection Objectives in either the road race Event or the time trial Event. Selected riders who the Selection Panel consider met the Selection Objective in the time trial Event must also ride in the road race Event;
- 4.1.3 may consider and take into account any one or more of the Discretionary Considerations; and
- 4.1.4 may consider and take into account any Extenuating Circumstances (in accordance with clause 8 of the General Selection Regulation)

5. Discretionary Considerations

- 5.1 The Selection Panel may consider any other information it considers relevant in considering the riders to select, such as:
 - a. any of the result(s) and performance(s) of the rider at any national and/or International Competitions, with priority given to results and performances in the Performance Window;
 - b. the riders’ potential to perform in future events including World Championships, Commonwealth Games and Olympic Games.
 - c. the technical, physical, and mental skills, of the rider which are relevant to the nature of the event, the course, and the environment of the 2024 UCI World Junior Road Championships;
 - d. the ability of the rider to train, compete and function with other riders in the Team;
 - e. the rider’s attendance, attitude and conduct at past competitions, training sessions, assessments and other events;
 - f. any other relevant matter that is reasonable to consider.

6. Key Timelines

- 6.1 The Junior (U19) Road Team will be selected in accordance with the Key Timelines set out below, unless Cycling New Zealand needs to change those dates for reasons outside of its control.
