

Addendum to Schedule 3A – Mountain Bike (DHI) – Elite and Junior (U19)

Selection for 2025 UCI MTB (DHI) World Championships

Date of Issue – 4 April 2025

1. Schedule 3A – Mountain Bike (DHI) – Elite & Junior (U19) and this Addendum

- 1.1 This Addendum is published in addition to Schedule 3A – Mountain Bike (DHI) – Elite & Junior (U19) (last updated **4 April 2025**), in response to the confirmation by the UCI of changes to the UCI MTB World Series, which have impacted a rider's ability to attend key selection events in 2025.
- 1.2 All Clauses in Schedule 3A apply to this Addendum, including the [General Selection Regulations](#) Selection Objectives and Additional Requirements, and these documents should be read together.

2. Tertiary Selection Criteria – Elite Riders – Men and Women

- 2.1 If there are quota places remaining after application of Clause 4.1 and 4.2 of Schedule 3A Mountain Bike (DHI) – Elite & Junior (U19):
 - 2.1.1 Elite riders who achieved a top 30 placing (women) or top 80 placing (men) in the 2024 UCI MTB (DHI) World Championships or a UCI MTB (DHI) World Cup competition during the Tertiary Performance Window, will be selected in order of their best result in those competitions.
 - 2.1.2 If riders are tied under clause 2.1.1, the rider with the most recent highest top 30 placing (women) or top 80 placing (men) in the 2024 UCI MTB (DHI) World Championships or a UCI MTB (DHI) World Cup competition during the Tertiary Performance Window will be selected.

3. Tertiary Selection Criteria – Junior Riders – Men and Women

- 3.1 If there are quota places remaining after application of Clause 5.1 and 5.2 of Schedule 3A Mountain Bike (DHI) – Elite & Junior (U19):
 - 3.1.1 Junior (U19) riders who achieve a top 10 placing (women) or top 25 placing (men) in the 2024 UCI MTB (DHI) World Championships or a UCI MTB (DHI) World Cup competition within the Tertiary Performance Window, will be selected in order of their best result in those competitions.

- 3.1.2 If riders are tied under clause 3.1.1, the rider with the most recent highest top 10 placing result (for women) top 25 placing result (for men) in the 2024 UCI MTB (DHI) World Championships or a UCI MTB (DHI) competition during the Tertiary Performance Window will be selected.
