Schedule 1B – Track – Para cycling
Selection for 2025 UCI Para cycling Track World Championships
Date of Issue – 6 June 2025

1. General Selection Regulation and this Schedule

- 1.1 This Schedule 1B is a schedule to the Cycling New Zealand General Selection Regulation (last updated 22 December 2024)(General Selection Regulation) for selection of the Para cycling Track Team for the 2025 UCI Para cycling Track World Championships.
- 1.2 Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Every reference to a rider in this Schedule means an Eligible rider, unless stated otherwise. Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise. If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

2. Selection Objective

- 2.1 Cycling New Zealand's selection objectives for the 2025 UCI Para cycling Track World Championships are in order of priority:
 - a. to win as many medals as possible in team and/or individual events;
 - b. to provide competition opportunities for those riders who have the greatest potential in the next two years to win medals at Pinnacle Events, and Commonwealth Games.

3. Eligibility Requirements

- 3.1 In order to be Eligible, all riders seeking selection to the Para cycling Track Team must complete the Rider Application by the date set out in clause 6 below.
- 3.2 Riders may be required to fund any competitions from which their results may count towards achieving selection.

4. Selection Criteria

- 4.1 In considering which riders satisfy the Selection Objectives, the Selection Panel:
 - 4.1.1 must give primary weight to riders who achieved a top four finish at the 2024 Paralympic Games (Paris, France 28 August 8 September 2024);
 - 4.1.2 must then consider riders who meet an 'A' Performance Standards (in Table 1 below) in their relevant Classification category in the Performance Window;
 - 4.1.3 must then consider riders who meet a 'B' Performance Standards (in Table 1 below) in their relevant Classification category in the Performance Window;
- 4.1.4 may consider any one or more of the Discretionary Considerations (listed in Clause 5); and
- 4.1.5 may consider any <u>Extenuating Circumstances</u>, injury, illness or other factors (in accordance with clause 8 of the General Selection Regulations).

5. Discretionary Selection Criteria

- 5.1 The Selection Panel may consider any other factors and information it considers relevant in considering the riders to select, such as:
 - a. an athlete's classification status;
 - b. an athlete's rate of improvement physiological, skill and cognitively;
 - c. a rider's progress towards their agreed individual performance objectives (such as in IPPs or similar), including how the rider has progressed against individual and event targets;
 - d. a rider's ability to win a medal in more than one Event;
 - e. the conditions in which results and performances were obtained, including but not limited to the nature of the velodrome, equipment used, environmental conditions, team composition, and/or level /field of competition;
 - f. the results of a rider's testing, assessment, training and other data collected both in and out of competition, during the Performance Window;
 - g. a rider's attendance and conduct at past competitions, training sessions, training camps, testing sessions, assessments, and other events;
 - h. a rider's performance behaviours, including active engagement in individual performance planning (IPP) or similar process, attention to detail, and ability to perform under pressure; and
 - i. the extent to which a rider has planned, and is committed to seeking, to compete in the 2025 UCI Para-cycling Track World Championships; has actively engaged with CNZ and is aligned with the Selection Objectives, including their reasons for wishing to be selected.

6. Key Timelines

The Paracycling Track Team will be selected in accordance with the Key Timelines set out below, unless Cycling New Zealand needs to change those dates for reasons outside of its control.
