Schedule 2A – Road – Para cycling Selection for 2025 UCI Para cycling Road World Championships Date of Issue – 6 June 2025

1. General Selection Regulation and this Schedule

- 1.1 This Schedule 2A is a schedule to the Cycling New Zealand General Selection Regulation (last updated 22 December 2024)(General Selection Regulation) for selection of the Paracycling Road Team for the 2025 UCI Para cycling Road World Championships.
- 1.2 Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Every reference to a rider in this Schedule means an Eligible rider, unless stated otherwise. Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise. If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

2. Selection Objective

- 2.1 Cycling New Zealand's selection objectives for the 2025 UCI Para cycling Road World Championships are in order of priority:
 - a. to win as many medals as possible in team and/or individual events and
 - b. to provide competition opportunities for those riders who have the greatest potential in the next two years to win medals at Pinnacle Events.

3. Eligibility Requirements

- 3.1 In order to be Eligible, all riders seeking selection to the Para cycling Road Team must complete the Rider Application by the date set out in clause 5 below.
- 3.2 Riders may be required to fund any competitions from which their results may count towards achieving selection.
- 3.3 Riders may be required to fund or partially fund (as agreed) themselves to attend and compete at the 2025 UCI Para cycling Road World Championships. (See clause 8 of the General Selection Regulation for conditional selections).

4. Selection Criteria - Men and Women

Selection of Riders (Men and Women) for the Team to compete at the 2025 UCI Para cycling Road World Championships is subject to available quota places and will be decided wholly on the basis of the following Objective Criteria:

- 4.1 Subject to clause 4.2 any rider who achieves a Top 4 placing at the Paris 2024 Paralympic Games (Road Cycling), or a Top 4 placing in a UCI Para cycling Road World Cup within the Performance Window (listed in Clause 5 below) will be selected.
 Where a riders result in one of the above competitions occurs in a race with eight or less riders, the rider must finish in the top half of the field.
- 4.2 If there are more riders entitled to selection under clause 4.1 than there are available quota places, riders will be selected in order of their highest top 4 placing at either the Paris 2024 Paralympic Games (Road Cycling) or in a UCI Para cycling Road World Cup within the Performance Window (listed in Clause 5 below) for the number of quota places available. Results at these competitions will be weighted equally.
- 4.3 If riders are tied under clause 4.2, the rider with the most recent highest top 4 placing under clause 4.2 will be selected.

5. Key Timelines

The Para cycling Road Teams will be selected in accordance with the Key Timelines set out below, unless Cycling New Zealand needs to change those dates for reasons outside of its control.
