Schedule 3A – Mountain Bike DHI Teams



1 September 2020

NOTICE: The Covid-19 situation continues to evolve both internationally and in New Zealand. As such there could be further changes to the international cycling calendar which could result in changes to these regulations.

This policy has been updated following the UCI's release of their Covid-19 health and safety protocols for UCI MTB events.

- 1. Athlete Nomination: All athletes seeking selection to the Team must complete the Athlete selection process by completing all information on the on-line Rider Application Form as prescribed in Paragraph 9 in this selection schedule.
- Selection prerequisite: Participation in the 2020 New Zealand National Championships at Dunedin from 24-26 January is mandatory for all nominees for selection unless agreed in writing by HPD or designate, pursuant to Clause 10 of the Cycling New Zealand General Selection Regulations.

3. Selection Process

- 3.1. Under this Schedule there will be no pool selection (Article 5 of the Cycling New Zealand General Selection Regulations 2017 2020) conducted by the Relevant Selection Panel. All applicants will go directly to the Team Selection Process.
- 3.2. When exercising its discretion about which (if any) of the factors set out in Article 8 of the Cycling New Zealand General Selection Regulations 2017 2020, the Selection Panel shall consider only the criteria in this Schedule.
- 3.3. There is no obligation on the Relevant Selection Panel to fill the maximum number of positions specified by the UCI, pursuant to the UCI MTB World Championship participation rules.
- **3.4**. Participation at the Mountain Bike events, is dependent on selected athletes being able to fund themselves.
- 3.5. Consideration will first be given to athletes who have registered Extenuating Circumstances as per Clause 10 of the Cycling New Zealand General Selection Regulations.

4. Primary Selection – Men and Women Elite

4.1 Any athlete finishing in the top 25% of the field at the 2019 MTB World Championships – DHI and who is competing in UCI events during the present UCI MTB DHI season.

5. Secondary Selection – Men and Women Elite

5.1 In the case where country quota has not been reached per the above mentioned conditions, any other athlete being selected to the team will be determined according to their individual UCI DHI ranking positions at the 2020 World Championships Team selection date. This selection process, by selecting the riders having the most points down to the riders having the least UCI points, will be followed through until all UCI quota spots, have been allocated or there are no more riders with UCI points.

6. Primary Selection – Men and Women U19

6.1. Any athlete being selected to the team will be determined according to their individual UCI DHI ranking positions for U19 riders at the 2020 World Championships Team selection date. This selection process, by selecting the riders having the most points down to the riders having the least UCI points, will be followed through until all UCI quota spots, have been allocated or there are no more riders with UCI points.

7. Secondary Selection – U19

- 7.1 The Secondary Selection applies in one of two circumstances being:
 - 7.1.1 Where more athletes would be entitled to selection pursuant to the Primary Selection than there are available national starting positions or;
 - 7.1.2 Where an athlete has not qualified for selection by the Primary Selection.
 - 7.2 Athletes eligible to be considered for selection under the Secondary Selection are to be ranked according to the following criteria:
 - 7.2.1 Any Top 5 positions achieved at the 2020 New Zealand National Championships and;
 - 7.2.2 Any Top 10 positions achieved in the 2020 Oceania Continental MTB Championships in the twelve (12) months immediately prior to the World Championships Team selection date.

8. Naming of alternates:

In considering the naming of alternates for the events mentioned in Paragraph 9, the Selection Panel will merely name the next best ranked athlete, according to their UCI individual points ranking position at the 2020 World Championships Team selection date, outside of the maximum quota permitted by the UCI per country.

9. International Mountain Bike Competitions where formal Selection is needed: Unless Cycling New Zealand decides otherwise, Mountain Bike Teams will be selected and named at the dates mentioned below. Teams will be selected to attend the International Mountain Bike Competitions listed in the table below:

10. Additional Competitions: Without limiting the Board's power under clause 1.5 of Cycling New Zealand's General Selection Regulations, HP Director, or designate, as applicable, may, in his/her sole discretion, decide to send Teams to compete in additional International Competitions as outlined in 6.3 of Cycling New Zealand's General Selection Regulations.

ADDENDUM

CYCLING NEW ZEALAND POSITION STATEMENT ON INTERNATIONAL CAMPAIGN AND PROJECT ACTIVITIES – UPDATE #3

31 August 2020

COVID-19 has had an unpreceded impact on the world. On the <u>15 July</u> and <u>17 August</u> Cycling New Zealand (herein referred to as CNZ) published position statements on international campaigns and project activities. In developing this position statement, consideration was given (but not exclusively) to how the pandemic has affected the general population worldwide, cycle racing, travel, short and long term health risks and CNZ's duty of care towards its members and staff. Along with recommendations from MFAT and the New Zealand Government.

On 24 August UCI published its protocol for the resumption of mountain bike competitions in 2020.

The document applies to all UCI-registered international competitions, in particular the UCI MTB World Championships of cross country, downhill, E-MTB and marathon and eliminator. In relation to the published protocols, CNZ has taken the following position:

- CNZ will NOT enter any riders in the 2020 UCI MTB World Championships, 2020 MTB Marathon World Championships and 2020 MTB World Cups unless they have 2020 contractual obligations with a UCI listed mountain bike team;
- Any riders named in national teams for any of these events are required to be based in Europe for at least <u>1 month prior</u> and to make their own arrangements with regard to entry exemptions and quarantine requirements for the countries they intend to travel to. Additionally, would be responsible for their own quarantine when returning to New Zealand;
- CNZ will NOT provide any New Zealand based staff for any of these events. Any riders named in national teams for these events will need to be solely reliant on their UCI teams for support. CNZ will facilitate entries as required and provide national team uniform. However, we strongly recommend all riders undertake their own personal risk assessment of the situation, and ensure they have support measures and plans in place should they find themselves in a changed circumstance;
- CNZ will work in collaboration with selected athlete's UCI trade teams to ensure staff can service riders during the events;
- Finally, for avoidance of doubt, CNZ will not enter any U19 (UCI Junior category) riders in any overseas events over which it has entry jurisdiction between now and 31 December 2020 (Regardless of any potential exceptions listed above).

CNZ continues to monitor the global situation and reserves the right to modify its approach to its activities at any time prior to the above events running.
