





2020 UCI Mountain Bike World Cup Entry Information

LICENCES and INSURANCE

All athletes must hold a current International Race Licence to be eligible for entry to any of the 2020 World Cup races. International race licences are available upon application from Cycling New Zealand

Riders are also free to organise their own insurance coverage to accompany the purchase of an international cycling licence. Riders must provide Cycling New Zealand with a letter or insurance certificate from their insurer stating that they hold medical cover and personal liability whilst cycle racing and training outside of New Zealand.

All riders must be registered using the UCI online registration system. If you are a member of an UCI ELITE MTB Team or UCI MTB Team they will register you. If you are eligible to enter following the above criteria your registration will be completed through Cycling New Zealand.

The on-line registration system generally opens twenty days before an event and closes on the Monday preceding the event at 12.00 am CET(as per 4.5.004 of the UCI Cycling Regulations).

The dates by which riders must advise Cycling New Zealand that they wish to be entered in the World Cups is in the Event Information below. We would appreciate your entry form to be received no later than 2 weeks prior to the desired competitions to get the entries processed in a timely manner.

Late entries from UCI ELITE MTB Teams, UCI MTB Teams and national federations are refused unless authorised by the UCI, subject to the above criteria, and on payment of a fine of CHF 300 for the first rider.

HOW TO ENTER

Independent entries (UCI ELITE MTB Teams or UCI MTB Teams will be entered by their teams) must be processed by the National federation (Cycling New Zealand) and entered through the UCI.

Please complete all this information at least one week prior to the UCI Registration Opening Date for each World Cup (as per the Entry Information at the end of this document).

Please note if you are applying for a supplementary spot this needs to be submitted as per the application date in the Selection Regulations. Further details can be found following in "How to Apply for a Supplementary Spot".

ENTRY FEES

Entry fees for World Cup events are payable at registration for the event and have been set at:

- XCO Elite and U23 €80 - DHI Elite €80 - DHI Juniors €40

IT IS NOT NECESSARY TO SEND ANY MONEY TO CYCLING NEW ZEALAND WHEN NOMINATING FOR ENTRY TO A WORLD CUP EVENT.

Any fines received by the rider during the event will be the responsibility of the rider to pay.

HOW TO APPLY FOR A SUPPLEMENTARY SPOT

In addition to completing the 2020 MTB World Cup entry form you will also need to complete the Rider Application Form as per the selection regulations.

If you are allocated a Supplementary Spot you will also need to race in NZ kit and sign a Cycling New Zealand athlete agreement. More details will be sent to you when you are advised if you have been allocated a Supplementary Spot.

ADDITIONAL INFORMATION

It is **important** that your full contact details are provided with any nominations for World Cup events. If you are travelling overseas you **must** also provide contact details for your overseas destinations. If you are unable to provide direct contact details please provide contact details for a third person that can be relied upon to relay any communications.

In addition to completing the online entry form, the following are required:

- Copy of Passport
- Details of your travel plans i.e. Flights / Transport / Accommodation for the event
- Copies of any medical certificates or TUE's relating to condition and medication.

These items must be held on file at Cycling New Zealand prior to your leaving. If a problem occurs while you are overseas, it will be much easier for us to help you if we have all this information!

Last minute changes to World Cup venues and event schedules do occur. Problems with entry details and event cancellation or relocation often require urgent communication with the athletes involved. Wherever possible, assuming we have an athlete's contact details, Cycling New Zealand will attempt to contact athletes with the necessary information.
