

Cycling New Zealand - Selection Regulations

Schedule 1 – Track Teams

17 January 2020



1. **Athlete Nomination:** All athletes seeking nomination to the Pool, and potentially selected to Track Teams must complete the Athlete Nomination process by completing all information on the on-line Rider Application Form as prescribed by Cycling New Zealand.
2. **Consideration for nomination the Track Pool:** All athletes seeking nomination to the Track Pool, for eventual selection to Teams for Events outlined in [Clause 6](#) of Schedule 1, who have completed the athletes nomination procedure outlined in [Clause 1](#) of Schedule 1 and who have met the minimum eligibility requirements outlined in Clause 4 (Eligibility) of Cycling New Zealand's General Selection Regulations must have met one or more of the following requirements:
 - 2.1. Considered by National Lead Track Coaches, or designate, based on, but not limited to:
 - 2.1.1 Coaches' recommendation to the High Performance Director.
 - 2.1.1.1 Future development potential
 - 2.1.1.2 Demonstrated ability to perform in specialist track events
 - 2.1.1.3 Demonstration of physiological ability through testing and training data
 - 2.2. National New Zealand Track Champion, in an Olympic event, at the most recent National Track Championships;
 - 2.3. Continental champion in an Olympic event at the most recent Continental championships;

Note¹: From the point where a rider has been nominated to the Pool for any event listed in [Clause 6](#) of Schedule 1, the HPD, or designate, will be required to communicate with Pool nominated rider on a regular basis¹. Once the Team is selected, the HPD, or designate, will focus most communication with Team selected riders.

Note²: All athletes nominated to the pool would also be notified by Cycling New Zealand of any

¹ In this context, "regular basis" is considered to be, at a minimum, on a monthly basis via email, phone, or other means of communication

3. Consideration to the Final Track Team Selection:

- 3.1 Only riders having been nominated to the Pool, based on considerations mentioned in [Clause 2](#) of Schedule 1 will be considered by the Selection Panel for selection to the Team for competitions outlined in [Clause 6](#) of Schedule 1.
- 3.2 In considering pool riders to be selected to the Team, the selection panel shall consider, but is not limited to, the following factors drawn from Cycling New Zealand's General Selection Regulations:
 - 3.2.1 Items mentioned in clause 2.2 (Overall Purpose)
 - 3.2.2 Items mentioned in clause 4. (Eligibility)
 - 3.2.3 Items mentioned in clause 8. (Factors)
 - 3.2.4 Items mentioned in clause 9. (Selection Trials)
 - 3.2.5 Items mentioned in clause 10. (Extenuating Circumstances)
- 3.3 There is no obligation on the relevant Selection Panel to fill the maximum number of positions specified by the UCI, pursuant to the UCI World Championship participation rules.

4 **Weighting:** Pursuant to Clause 7.2 of Cycling New Zealand's General Selection Regulations, the relevant Selection Panel, when going through the Team selection process, will put more weight on any results or performances of a rider in the following events over the course of the UCI season that coincides with dates mentioned in [Clause 6](#) of Schedule 1.

- 4.1 UCI World Cup² events
- 4.2 UCI C1² events
- 4.3 Oceania² Championships

5 **Naming of alternates:**

- 5.1 Only riders having been nominated to the Pool, based on considerations mentioned in [Clause 2](#) of Schedule 1 will be considered by the Selection Panel as alternate (s) to the Team for competitions outlined in [Clause 6](#) of Schedule 1.

² Compatibility of track length and type of surface to that of competition mentioned in Clause 6 will be taken in consideration

5.2 In considering Pool riders to be selected to the Team as alternates, the selection panel shall consider, but is not limited to, the following factors drawn from Cycling New Zealand's General Selection Regulations:

5.2.1 Items mentioned in Clause 2.2 (Overall Purpose)

5.2.2 Items mentioned in Clause 4. (Eligibility)

5.2.3 Items mentioned in Clause 8. (Factors)

5.2.4 Items mentioned in Clause 9. (Selection Trials)

5.2.5 Items mentioned in Clause 10. (Extenuating Circumstances)

6 **International Track Competitions where formal Selection is needed:** Unless Cycling New Zealand decides otherwise, Pool nominations and Track Teams will be selected and named at or before the dates mentioned below. Teams will be selected to attend the International Track Competitions listed in the table below:
