

# Cycling New Zealand - Selection Regulations

## Schedule 3F – Cyclo-Cross (CX) Teams

December 2019



1. **Athlete Nomination:** All athletes seeking selection to the Team must complete the Athlete nomination process by completing all information on the online Rider Application Form by the deadlines prescribed in section 6 of this selection schedule.
  
2. **Selection Process:**
  - 2.1. Under this Schedule there will be no Pool selection (Article 5 of the Cycling New Zealand General Selection Regulations 2017 – 2020) conducted by the Relevant Selection Panel. All applicants will go directly to the Team Selection Process.
  
  - 2.2. When exercising its discretion about which (if any) of the factors set out in Article 8 of the Cycling New Zealand General Selection Regulations 2017 – 2020, the Selection Panel shall consider only the criteria in this Schedule.
  
  - 2.3. There is no obligation on the Relevant Selection Panel to fill the maximum number of positions specified by the UCI, pursuant to the UCI Cyclo-Cross World Championship and UCI Cyclo-Cross World Cup participation rules.
  
  - 2.4. Participation at the Cyclo-Cross events, is dependent on selected athletes being able to fund themselves.
  
3. **Weighting:** Pursuant to Clause 7.2 of Cycling New Zealand's General Selection Regulations, the relevant Selection Panel, when going through the Team selection process, will select final Team based on priority listing mentioned in section 4 of this Schedule (Schedule 3F).

#### 4. Selection priority listing for World Championships:

Team selection for the 2020 Cyclo-Cross World Championships will be offered to riders in the following priority order:

- 4.1. Any eligible athlete who finished on the podium at the 2020 Cyclo-Cross National Championships (held in Christchurch on 11 August 2019), in the order of placings (winner gets first offer).
  - 4.1.1. In the case where the country quota has not been reached as per the above mentioned condition, any other eligible rider who finishes in the top 30 at a Cyclo-Cross World Cup in the current season, in order of best individual result.
  
  - 4.1.2. In the case where the country quota has not been reached, as per the above two mentioned conditions, any other eligible rider who finishes in the top 3 at UCI C1 or C2 cyclo-cross events held in Asia-Pacific (for example but not limited to the Melbourne Grand Prix of cyclo-cross (Australia), Qiansen Trophy Cyclocross (China), Rapha Supercross Nobeyama (Japan)).

## 5. Selection priority listing for World Cups:

Selection for the 2019-2020 Cyclo-Cross World Cups will be offered to riders in the following priority order:

- 5.1. Any eligible athlete who finished on the podium at the 2020 Cyclo-Cross National Championships (held in Christchurch on 11 August 2019), in the order of placings (winner gets first offer).
- 5.2. In the case where the country quota has not been reached, as per the above mentioned condition, any other eligible rider who finished in the top 3 at the 2019 Fields of Joy Cyclo Cross C2 event in Australia (also known as the Melbourne Grand Prix of Cyclo-Cross).

## 6. International Cyclo-Cross Competitions where formal Selection is needed:

Cyclo-cross Teams will be selected and named at the dates mentioned below, unless Cycling New Zealand requires to change dates due to reasons out of its' control:

## 7. Additional Competitions:

Without limiting the Board's power under clause 1.5 of Cycling New Zealand's General Selection Regulations, HP Director, or designate, as applicable, may, in his/her sole discretion, decide to send Teams to compete in additional International Competitions as outlined in 6.3 of Cycling New Zealand's General Selection Regulations.
