Trade Teams – Still working on the issues raised at the AGM. Skoda has been in contact with CNZ as well and sent a further email seeking clarification on regulations around entry criteria. Some questions around team contracts and any potential conflict with CNZ/UCI Regulations. Discussion around whether there are age limits for team riders and what protection there is for U17 riders.

Function of Centres – gathering resource materials as per AGM discussion, target for presentation back to Council is the August meeting. MS to track down the Club "tool box" information produced by CNZ.

Additional track events – not actioned yet, with the Events and Technical Panels

Development teams are looking at Road events, the track is ongoing already Lower North Island Hub is still a work in progress at present
