DOPING CONTROL STATION REQUIREMENTS

DOPING CONTROL STATIONS (DCS) NEED TO BE PRIVATE; I.E FACILITIES FOR DRUG TESTING MUST PROVIDE PRIVACY FOR COMPETITORS AND SECURITY FOR THE COLLECTION PROCEDURES. IT SHOULD BE SITUATED CLOSE TO THE COMPETITION OR TRAINING AREA. ACCESS TO THE DCS IS RESTRICTED TO AUTHORISED PERSONNEL ONLY (I.E TESTING OFFICIALS, THE SPORT LIAISON OFFICER, COMPETITORS AND THEIR REPRESENTATIVES AND/OR INTERPRETERS). **THE ENTRY DOOR TO THE DCS MUST BE SECURE AND LOCKABLE WITH THE KEY BEING HELD BY THE DOPING CONTROL OFFICER, SPORT LIAISON PERSON OR A SECURITY GUARD.**

The DCS should have three areas: a waiting area; administration area; and toilet area.

- The **waiting area** should be equipped with chairs, table space for an adequate supply of sealed drinks and a rubbish bin. In instances where there are going to be large numbers of tests, the provision of reading material and a radio are helpful to create a relaxed atmosphere.
- The **administration area** must contain a table and three chairs. At major events, where testing is done over several days, a lockable freezer or refrigerator for storage of samples is useful.
- The **toilet area** must be able to accommodate two people - the Chaperone and the competitor. This area must also have a wash hand basin, soap and towels. At major events where testing is done over several days, arrangements should be made to have the toilets and toilet area cleaned daily.

Note:

1. Portable disabled only toilets are acceptable for drug testing purposes.
2. Drinks for the competitors will be provided by Drug Free Sport NZ.

Additional Requirements for Athletes with a Disability

When DFSNZ is, or may be, testing athletes with a disability, the following special requirements apply:

- **The Doping Control Station:** Must be accessible by wheelchair and be on the same level as the competition area.
- **The toilet area:** In addition to the requirements for able bodied athletes above (i.e the toilet must be a disabled person's toilet), the toilet must be dedicated for use only by Doping Control and be large enough to accommodate 3 adults – the athlete, the Chaperone and the athlete's representative should the athlete require assistance in the toilet.
- **Additional Room:** Where ever possible, there should be an additional room set up with at least one bed, blankets, heating in winter, pillows and two chairs.
