## Membership - Update with/from MR

Need to ensure the process for the implementation keeps moving

The cost of not implementing the new structure will be the continued reduction in membership numbers and fees. Any cost to implement the new structure is an investment in the future growth of membership and should be viewed as an investment in the future and not as a cost.

#### Traffic Management

Following the request made for an update as to where things were at with regards to Traffic management, CNZ and NZTA now JD is no longer with CNZ, we were advised that Charlotte Pearson is leading the events team at the moment.

#### Master Track National – Additional Events

EC expressed concern that CNZ pushed very hard to take control of the National level events and are now pushing back because of financial constraints. SS and MS reiterated that to have a sport we need events and schools events are at the crucial age for the grass roots foundation of our sport
