 - 6.4.1 Agreed to use the brand "RTX" going forward, to encompass Road, Track, Cyclocross and E-Sports.
- 6.5 Partnership Agreement
 - 6.5.1 This is currently sitting with JD. Agreed that it would be good to have a draft in place for when the new CEO is appointed

7. Other business

- 7.1 AGM Proposed date 22nd May, will be in Cambridge and will again also be virtual for those that wish to join on-line. Workshop topic to be the proposed membership options for 2023 and any changes required to support those. Workshop to be Saturday afternoon, AGM Sunday morning, with the CNZ AGM to follow.
- 7.2 Board nomination the current Board member that we nominated will finish their term at the upcoming CNZ AGM. A possible nomination was discussed and fully endorsed by Council. EC will contact the other Member Organisations to see if they would support that nomination.
- 7.3 Selection Policy This is sitting with BT, who will endeavour to follow up on this in the coming week.

7.4 Road Development and Road Riders

- 7.4.1 HPSNZ and CNZ are removing all support for road riders under new TAPS system. Although our elite road riders only received access to services and potentially PM scholorships under previous carding this has now been removed. Council has been in discussions with CNZ and talked with athletes. We need to raise our concern and support our member road riders to help advocate for them in this matter.
- 7.4.2 SS updated the meeting on discussions he has had on UCI level events in NZ. Several options being looked at, these were endorsed by Council. We need to rebuild the calendar of events for our top level athletes, having lost so many events over the last 2 years due to government restrictions.

7.5 Timing of National Championship Events

- 7.5.1 As part of the ongoing review of events, the timing of Elite Road Nationals and potentially Oceanias is being looked at. A key focus should be to ensure the timing suits our Elite Road riders do have the oppurtunity to compete. The UCI Calendar does make this difficult at times. SS to contact AusCycling to get their thoughts on a calendar of events that would work across both Australia and New Zealand.
- 7.5.2 Discussions going well with a prospective host for the 2023 Elite Road Champs and the Criterium Champs.
- 7.5.3 Age Group Roads the current Covid restrictions (Red Traffic Light) could impact the AGRN, due to limit of 100 competitors. CNZ is monitoring the situation and looking at all options. Council fully endorses and supports the options that the CNZ Events team has proposed.
- 7.5.4 Action SS / PH / JD to formulate the "high level" events calendar for key events for our top level atheletes

- 9.2 **Events** Already discussed under 7.4 and 7.5. Noted that entries for the new Masters Track Champs are quite good. Elite Track entries are still open, Noted

that RATs testing is being considered as one of the tools used to keep everyone safe at these events

- 9.3 Athlete Development (incl selectors & Hubs) (BT) already covered under 5.1 Correspondence and 7.3.
- 9.4 **Diversity in Cycling** (PH) There are some opportunities for women at the Mixed Relays at the Worlds. PH had contacted Amy Taylor at CNZ and had received a very positive response on this and Womens development in general. Some development opportunities may be available in Europe, this is being worked on.

Council noted very positive and productive meetings with Amy in her new role.
