## 7. Hui update

## 9. Panel Reports

## 9.1 Technical Panel (MI)

- 9.1.1 Regional Commissaire course was held in Auckland, with 16 new Commissaires trained, and now awaiting some practical training opportunities. The ChCh course scheduled for last weekened has been postponed to a later date, along with the Invercargill date, both still to be determined.
- 9.1.2 Elite National course UCI has accepted Olivia Spaans (Track), while due to the number of applicants, Mark Reynolds (Road) will need to complete a pre-qualification exam.
- 9.1.3 Expressions of Interest for Criterium Nationals, Tour of Southland, Cambridge 3 Day have been received, Panel to review and make appointments.
- 9.1.4 Jeremy Christmas has offered to be the on the Technical Panel as the CX specialist.

## 9.2 Events

- 9.2.1 All the major Championships for the 2021/2022 season have been locked in place. JD asked Council about a request from the host of the Elite Roads about a "back-up" date, which they would like to have in case of a lockdown.
- 9.2.2 SS noted that with the Worlds in Wollongong in 2022, there are opportunities for NZL to be involved and these should be explored Suggested that a NZL event staged around that time might be able to attract some riders to this side of the Tasman

### 9.4 Diversity in Cycling – (PH)

- 9.4.1 PH has been working with Janette Douglas and Graeme Hunn and event organisers to see if we can get inclusion of U23's into the NRS to help invigorate womens cycling.
- 9.4.2 A survey of U19 riders came back with a majority support of this concept as did most of the event organisers.

- 9.4.3 PH has reached out to other event organisers in the South Island such as 2 Day Timaru and Fight For Yellow about adding NRS to their race especially from a girls / women's perspective so we have one more South Island round. Positive feedback so far but nothing concrete.
- 9.4.4 There are concerns with the calendar re NRS at present especially around the March / April timeframe - unlikely we will get a good turnout with pressure to be ready / perform at the Nationals and Oceania events around that time.
- 9.4.5 Dynamo cancelled elite women's grade and would not allow some women's teams to enter in Open women's grade. There is no teams racing available for 'elite' women at the moment, we are hoping Southern Calder Stewart replacement series will happen.
- 9.4.6 Followed up with CNZ why no NZ team entered in mixed team relay at Road Worlds as riders are very keen (especially women). This is a missed opportunity as it will possibly become an Olympic sport in the future. No response on this yet. Need to follow-up on this for the future

## 9.6 Emerging Platforms – (Kim)

- 9.6.1 CX Nats was held in Hutt Valley last weekend
- 9.6.2 The Junior Women's CX National Jersey was awarded for the first time (new UCI category)
- 9.6.3 The event had an 80% increase in participation compared to the last CX Nats (2019 due to COVID interrupting 2020)
- 9.6.4 The women's participation doubled compared to previous CX Nats (41 women)
- 9.6.5 The racing was high calibre with strong competition for podiums right across age grades as well as in UCI categories
- 9.6.6 Our new NZ National CX Champions are: Seana Gray (WJ), Coen Nicol (MJ), Kate McIlroy (WE), Josh Burnett (ME)
- 9.6.7 There are 2x affiliated CX clubs in NZ who have a handshake agreement to alternate hosting to ensure it is sustainable. Both clubs would like to help other CX clubs become affiliated
- 9.6.8 Almost 50% of entries for CX Nats were using one-day licences. Having not previously been a fan of one-day licences (mainly because I have never seen evidence of them increasing participation), I may have to Uturn on my position as I would certainly like to see us further extending the participation base at this event in future years
- 9.6.9 Initial survey feedback has been very positive from participants I will share it when it has all been collated

9.6.10 The event was delivered at a high standard (appropriate for a sanctioned National Championships), cost \$19k and broke even
