This is for all countries as at 25 th January 2021. MIQ charges are still \$3100 per person. All travellers entering NZ are also required to: • Hold a managed isolation voucher, secured via the new allocation system. If you do not hold a voucher, you will be refused boarding. • go into 'managed isolation' in a government-provided facility (hotel), or • if you have COVID-19 symptoms, go into a quarantine facility (separate hotel). • You will need to stay there for at least 14 days. This will prevent any further unmanaged COVID-19 infection coming into New Zealand. You can't self-isolate at home or take a domestic flight before the 14-day period is completed. |

Provide a pre-departure test – within 72
hours of departure – A positive test result
means you may not be able to travel. If you
test positive, you may not be able to board
your flight. You should postpone your travel
and follow local public health advice. If you
choose to travel at a later date when you
have recovered, you will be required to get a
medical certificate within 72 hours from the
time of departure that confirms that you had
a positive COVID-19 test but have now
recovered.



Passengers must have a document showing a negative COVID-19 test result to enter Turkey. Either:

- PCR test taken in the last 72 hours
- Rapid antigen test taken in the last 48 hours Fully vaccinated and recovered patients are exempt if they can provide either:
 - Vaccination certificate showing the last dose was given at least 14 days before arrival
 - Medical certificate showing recovery in the last 6 months

There are additional rules for those from high-risk countries





Turkey Confirmed Cases – 6,498,054 Deaths – 58,106 Daily new cases – 20,000 per day

Turkey is going through a spike in cases at present with over 20,000 per day and 280-300 deaths per day. The death rate is almost at the same rate as when Turkey had its biggest spike back in April 2021.

Assessment Notes/Recommendations

Key Points:

- Turkey is currently going through a third, sustained spike in cases with around 20,000-24,000 cases per day which has been happening for over a month now. The death rate per day is also continuing to rise to close to levels of the April outbreak.
- Information from the Government and other websites was not easy to gather, which leaves some gaps in the ability to be able to fully assess the event. Including not being able to access the Ministry of Health for Turkey website https://covid19.saglik.gov.tr/
- The event is <u>not</u> requiring anyone to have a mandatory test prior to coming onsite, although there will be mask requirements and requirements around bubbles there is a higher chance of contracting COVID with potential COVID positive cases being able to access the event.
- MIQ to return to NZ is currently on hold and is becoming increasingly harder to access/gain a spot.

It is important to note:

- NZ government is still recommending not to travel. Leaving NZ carries increased risk.
- COVID19 is still an unknown virus and can escalate extremely quickly, this could result in difficulty in getting back home to NZ should there be an outbreak and also treatment at a hospital could be impacted for not only COVID19 related symptoms but other injuries.
- If an athlete contracts COVID19 they will be quarantined for a minimum of 10 days, which is a financial risk as well as impacting training significantly for future events

RECOMMENDATION TO CYCLING NEW ZEALAND

As at 6 September it is recommended that Cycling New Zealand do <u>not</u> allow entry into the Turkey BMX World Cup due to the above reasons.

REVIEWED RECOMMENDATION TO CYCLING NEW ZEALAND

The situation in Turkey was reviewed on 1 October 2021. Based on the reasons for why it was delcined previously, the following has been reveiwed:

- Daily Case numbers these have increased since the last assessment to be consistently between 27,000 30,000 cases per day.
- Daily death numbers have remained the same as the previous assessment around 200-300 per day
- There is no change to the events COVID plans. The event still is not requiring anyone to produce a negative test to enter the event, it is still only a recommendation.

Given there is no material change to the COVID plans nor has there been a decline in case numbers the recommendation remains that CNZ do not approve entry for this event

STEP ONE

Create an individual or family registration

Enter passenger details. For family registrations, enter the details of everyone in your group who is travelling to New Zealand with you. STEP TWO

Hold your accommodation

Select your preferred arrival date in New Zealand. A 14-day stay in managed isolation will be held for 48 hours while you organise your flights.

STEP THREE

Confirm your arrival details

Book your flights then return here to enter your flight details to New Zealand. Your allocation in managed isolation will be confirmed.

STEP FOUR

Print or download your Voucher

You will need to present your Managed Isolation Allocation Voucher at the airport to board your flight to New Zealand.
