

Cycling New Zealand Selection Regulations

Schedule 2 – Road Teams

18 October 2017

1. Athlete Nomination: All athletes seeking selection in Road Teams must complete the Athlete Nomination process by completing all information on the on-line Rider Application Form as prescribed by Cycling New Zealand.

2. Competitions and Selection Dates

2.1. **Competitions:** Unless Cycling New Zealand decides otherwise, a Road Team (for the Road and Time Trial Events) for riders will be selected (by the Selection Dates) to attend the following International Road Competition:

International Road Competition	Competition Date	Selection Date* (refer to 2.2 below)
2018 UCI Road World Championships, Innsbruck-Tirol, Austria	22 - 30 September 2018	7 September 2018

2.2. **Selection Date:** The names of riders selected to the Road Team will be announced on or before either the later of the date stated in 1.1 above or 5 days after the UCI publish the qualification quota for this category.

2.3. **Oceania Championships:** Cycling New Zealand will not be selecting any Team to compete in the 2018 Oceania Championships (CC) to be held in Tasmania from 23 – 25 March 2018, where entry is open to all riders who fit the eligibility requirements outlined in the Selection Regulations.

3. Specific Terms:

- 3.1. **Team Size:** The maximum size of the team for the Road Team at the International Road Competition specified in this Schedule is as follows or whatever number is determined by the UCI in accordance with UCI Regulations, or the relevant Selection Panel as noted in clause 6.5 of the Selection Regulations:

Under 23 Men	3	2
Under 19 Men	3	2
Under 19 Women	4	2

- 3.2. **Eligibility:** U23 riders cannot compete in both the Elite Men and U23 Men International Road Competitions specified in this Schedule.
- 3.3. **Selection to More than One Event:** Riders may be selected for the Road Event and/or the Time Trial Event but selection to one Event does not guarantee selection to the other Event.
- 3.4. **Pre-Condition:** All riders seeking selection to the Elite Women, U23 Men and U19 Men and Women Road Team must complete an international participation period of at least three (3) months in a team training and racing programme approved by Cycling New Zealand prior to the International Road Competition for which the Road Team is being selected, or have a preparation plan approved by the relevant Selection Panel before 20 July 2018.

4. Weighting of Factors:

- 4.1. **Elite Men:** In considering the Elite male riders to be selected to the Road Team under this Schedule, and considering the Factors in accordance with clause 7 of the Selection Regulation, the Road Selection Panel must put more weight on any results and performances (which may or may not include ranking points) of a rider in the following competitions on the UCI calendar in the 12 month period prior to the Selection Date:
- a. the UCI Oceania Tour;
 - b. the UCI World Tour; and,

c. the other Continental Tours.

- 4.2. **Elite Women:** There is no weighting of the Factors in selecting riders to the Elite Women's Road Event or Time Trial Event.
- 4.3. **Under 23 Men:** There is no weighting of the Factors in selecting riders to the U23 Men's Road Event or Time Trial Event.
- 4.4. **Under 19 Men and Women:** There is no weighting of the Factors in selecting riders to the U19 Men's and Women's Road Event or Time Trial Event.
